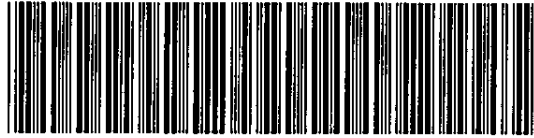

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is LESLIE O'NEAL, P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business as an attorney at law.

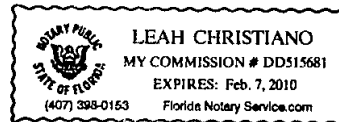
