In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: STONEWALL ORLANDO, INC.

ARTICLE II

The existence of the Corporation shall begin on: June 15, 2007.

ARTICLE III

The street address of the principal office of the Corporation is: 741 West Church Street, Orlando, FL 32805.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$0 per share, all of which shall be Common Shares. 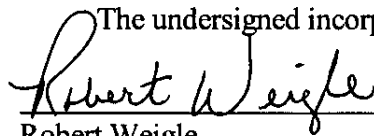

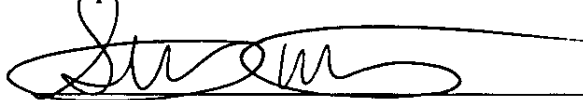

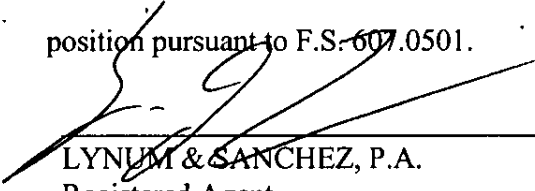
