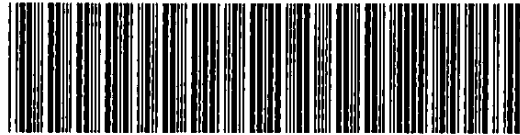

**ARTICLES OF INCORPORATION  
OF  
SYNC LOGISTICS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is Sync Logistics, Inc.

**ARTICLE II**

The street address of the principal office and mailing address of the Corporation is 3031 Camino Real Drive South, Kissimmee, Florida 34744.

**ARTICLE III**

The maximum number of shares this Corporation is authorized to issue is 1,000,000 shares, having no par value, and all of which shall be Common Shares. 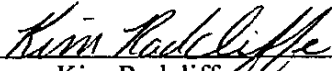
