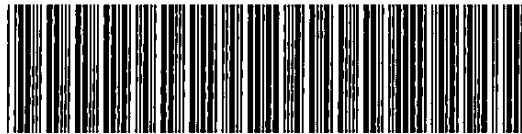

**ARTICLES OF INCORPORATION
OF
JARMAN DEVELOPERS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing and conducting any and all lawful services in the State of Florida.

ARTICLE I

The name of the Corporation is: Jarman Developers, Inc.

ARTICLE II

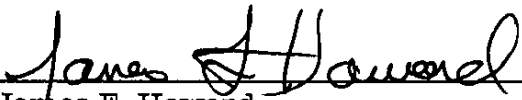
