ARTICLES of AMENDENT to ARTICLES of INCORPORTION

PURSUANT TO FLORIDA STATUTES SECTION 607.1006, this Florida profit corporation hereby adopts the following amendment to its Articles of Incorporation:

Amendment of Article III as to Purpose. Lexington Exports, Inc. hereby amends its Articles of Incorporation to restate Article III thereof as to its corporate purpose, deleting in the entirety said Article III of the Articles of Incorporation and replacing same with the following:

Mission. The purpose of the Corporation is and shall be to serve as an active marketing, sales, and service agent for the sale of domestically manufactured products to customers based outside the United States for the ultimate distribution and consumption of said products outside the United States. In effectuating same, the Corporation may purchase domestically manufactured products for resale to customers based outside the United States, and/or it may provide marketing, account servicing, and other services necessary to or supportive of the sale of domestically manufactured products to customers based outside the United States. The Corporation may acquire, receive, own, lease, and otherwise deal in any real property and personal property necessary or convenient to achieve its business purpose, and to perform all such other related activities necessary to or supportive to said purpose as may be permitted for a Corporation under the laws of the United States and the State of Florida.

<u>Date of the Amendment.</u> The Shareholders of the Corporation adopted this Amendment on June 18, 2007.

Adoption of the Amendment. The Shareholders of the Corporation adopted this Amendment by unanimous vote and otherwise in a manner sufficient for approval.
