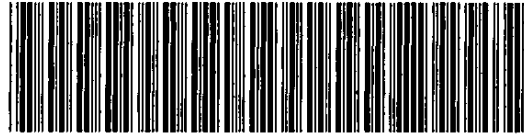

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is: BETTER BANKRUPTCY.COM , INC.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS

The corporation may engage in any activity of business permitted under the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is Two Hundred (200) shares. Such shares shall be common stock of single class, and shall have a par value of \$1.00 per share. Percentage of stock ownership is the basis for profit/loss distribution and corporate ownership.
