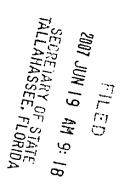

THE UNDERSIGNED Subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a personal service corporation for profit under the laws of the State of Florida, pursuant to Chapter 621, *Florida Statutes*, and further agrees to the following conditions of said Corporation.

ARTICLE I: NAME

The name of the Corporation is: Zakir Patel, M.D., P.A.

ARTICLE II: NATURE OF BUSINESS
