**ARTICLES OF INCORPORATION
OF
THOMAS CASSIDY, P.A.**

The undersigned natural person, of whom is licensed or otherwise legally authorized to practice the profession of law in the State of Florida, hereby associates himself with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopt the following articles of incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation shall be **THOMAS CASSIDY, P.A.**

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State. This corporation's duration shall be perpetual or until dissolved on a vote of the shareholders as hereafter provided.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of the practice of the profession of law. The sole and exclusive professional service to be rendered by the corporation is the practice of law.

ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue 1,500 shares of stock. Such shares shall be of a single class of common stock and shall be without par value.

ARTICLE V. CAPITALIZATION

The amount of capital with which the corporation will begin to practice the profession of law or perform the service or attorney at law or legal counsel is not less than One Thousand Five Hundred and no/100 (\$1,500.00) Dollars.

ARTICLE VI. PRINCIPAL OFFICE

The address of the corporation's principal office is 1249 Lake Point Dr., Lakeland, FL 33813 The name and address of the initial registered agent of the corporation is THOMAS CASSIDY, ESQUIRE, whose office address is 1249 Lake Point Dr., Lakeland, FL 33813

ARTICLE VII. CORPORATE POWERS

The corporation shall have all the rights and powers now or hereafter conferred on professional corporations by the laws of the State of Florida, including but not limited to, the following:

To engage in the practice of law as a professional law corporation and to carry on services incident thereto. The practice of law is the sole and exclusive professional service to be rendered by this corporation;

To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation;

The professional services of this corporation shall be carried out only through officers, employees, agents, each of whom has been admitted to the bar of, and is duly authorized to practice law in, the State of Florida;

The professional corporation is not prohibited from investing its funds in real estate, mortgages, stocks, bonds or any other type of investments, or from owning real or personal property necessary or incidental to the rendering of professional services.

ARTICLE IX. DIRECTORS

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is one, and the name and address of the initial director is:

The initial director shall hold office until their successors are elected and qualify as provided by the bylaws. Thereafter the term of office of each director shall be annually continuing until the election and qualification of a successor. The number of directors set forth herein and constituting the initial board of directors shall be the authorized number of directors until such number is changed by a bylaw duly adopted by the shareholders.

ARTICLE X. BYLAWS

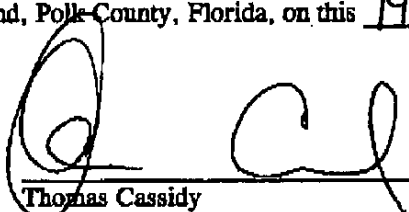
The initial directors shall submit the proposed bylaws to the shareholders at a meeting to be held for that purpose not more than ninety (90) days following the issuance of the Certification of Incorporation. Following the adoption of bylaws by a majority vote of the shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with such bylaws.

ARTICLE XI. DISSOLUTION

This corporation may be dissolved at any time (1) by unanimous written consent of the shareholder; or (2) on the affirmative vote of the holders of at least fifty percent (50%) of the outstanding shares of the corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him.

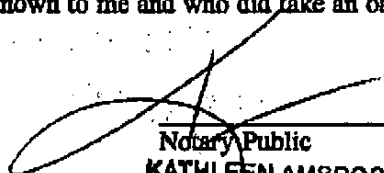

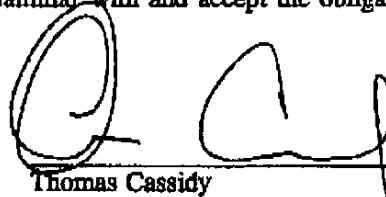
