**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be Atlanticblue, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 122 E. Tillman Avenue, Lake Wales, Florida 33853. The mailing address of the Corporation shall be P. O. Box 1318, Lake Wales, Florida 33859-1318.

ARTICLE III - CAPITAL STOCK
