ARTICLES OF INCORPORATION
OF
DOORS N SERVICES, INC.
A FLORIDA CORPORATION

The undersigned, acting as Incorporator of DOORS N SERVICES, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of the Corporation is DOORS N SERVICES, INC. and the street address of the initial principal office of the Corporation is 4705 NW 76 Street, Coconut Creek, FL 33073.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue One Hundred Thousand (100,000) shares of \$.001 par value Common Stock.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT
