

ARTICLE I

Name and Duration

The name of the TMB TRANSPORTATION IMPORT & EXPORT, INC The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

Corporate Purposes, Powers and Rights

1. The nature of the business is trucking and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.




