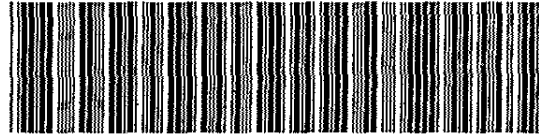

O'DONNELL ENTERPRISES, INC., a Florida corporation (the "Corporation"), by and through its President, hereby adopts an amendment to its Articles of Incorporation of June 21, 2007, as hereinafter set forth.

1. Pursuant to Section 607.1003 of the Florida Statutes, the Board of Directors of the Corporation and the shareholders of the Corporation, in accordance with Sections 607.0821 and 607.0704 of the Florida Statutes, on October 1, 2007, adopted an amendment to Article I of the Articles of Incorporation of the Corporation. Article I is deleted in its entirety and the following is substituted therefor:

ARTICLE I - NAME

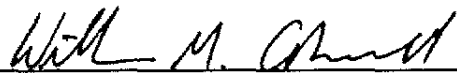
The name of this Corporation shall be:
