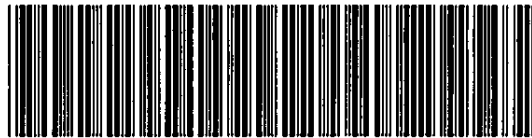

OF

Each of the undersigned for profit business entities adopts the following Articles of Merger in accordance with Chapter 607, Florida Statutes, and 15 Pa.C.S.A. § 8957:

1. Names of Parties. The names of the entities that are parties to the merger are as follows:

Informed Medical Decisions, LLC, a Pennsylvania limited liability company (the "LLC"), and Informed Medical Decisions, Inc., a Florida corporation (the "Corporation").

2. Surviving Corporation. The surviving entity of the merger shall be:

Informed Medical Decisions, Inc., a Florida corporation.

3. Articles of Incorporation. The surviving corporation shall be governed by the Articles of Incorporation of the Corporation.

4. Adoption of Agreement and Plan of Merger.

(a) By Members of the LLC. An Agreement and Plan of Merger dated July 13, 2007 (the "Plan") was adopted and approved by all the members of the LLC in accordance with the laws of Pennsylvania and Florida by the execution of a written consent at a meeting of the members on July 13, 2007.

(b) By Shareholders of the Corporation. The Plan was adopted and approved by all the shareholders of the Corporation by the execution of a written consent dated July 13, 2007.

(c) Effective Date. The merger provided herein shall be effective as of July 20, 2007.

5. Conversion of Issued and Outstanding Membership Interests in LLC. All of the issued and outstanding membership interests in the LLC shall cease to be outstanding and shall be converted into fifty thousand (45,000) newly issued shares of the Corporation.
