




FIRST: *The articles of incorporation of the Corporation shall be amended and restated to read as set forth on the attached Exhibit A.*

AMENDED AND RESTATED ARTICLES OF INCORPORATION OF
INFORMED MEDICAL DECISIONS, INC.

ARTICLE I
NAME

The name of the corporation is Informed Medical Decisions, Inc.

ARTICLE II
PRINCIPAL OFFICE

ARTICLE III
