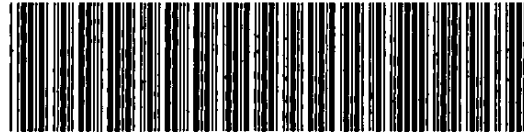

The name of this corporation is HARTLEY AUTOMOTIVE, INC.






