The effective date of the adoption by the Directors, Shareholders and Officers of the above mentioned Amendments was June 30, 2008.

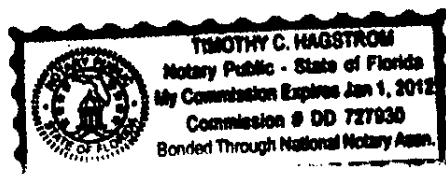
