The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I - NAME

The name of the Corporation shall be AFFORDABLE APPLIANCE REPAIR AND AIR CONDITIONING, INC. The street address of the initial principal office address of the Corporation shall be 5805 – 8th Avenue Drive West, Bradenton, Florida 34209 and the mailing address shall be the same.

ARTICLE II - PURPOSE AND POWERS
