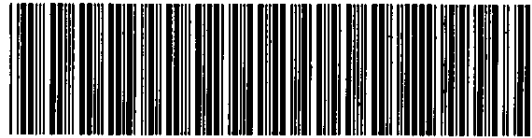

**ARTICLE 1 - NAME**

The name of this corporation is **DAVID J. PETRANTONI, P.A.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended. Specifically, the corporation is organized for the purpose of conducting real estate transactions and sales.

**ARTICLE IV - CAPITAL STOCK**


