

ARTICLES OF INCORPORATION For 3155 West Coast Realty Development, Inc.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is 3155 West Coast Realty Development, Inc. Principal place of business is 8746 Caraway Lake Court, Boynton Beach, Florida 33437.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
