ARTICLE I

The name of the corporation shall be

ARTICLE II

The purpose for which this corporation is organized is to engage in any activity that is legal under the laws of the United States and the State of Florida.

ARTICLE III

ARTICLE V

The maximum number of shares that this Corporation is authorized to have outstanding at any time is **FIVE-HUNDRED THOUSAND (500,000)** shares with two classes only.
