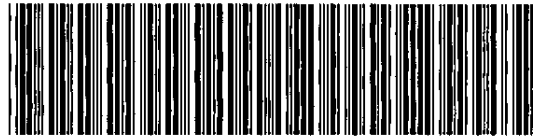

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is CHANDLER D. DORA M. D., P. A. and its principal place of business shall be located at 2727 West Martin Luther King Blvd., Suite 590, Tampa Fl. 33607.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing professional urology services by duly licensed urology physicians pursuant to Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Thousand (1000) shares of common stock at one dollar (\$1.00) par value, which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 2727 West Martin Luther King Blvd., Suite 590, Tampa Fl. 33607 and the name of the initial registered agent of this corporation at that address is Chandler D. Dora M.D.

ARTICLE VII - DIRECTORS

Initially, this corporation shall have one (1) Directors who shall serve until their successors shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall

have no less than one (1) director constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the Bylaws. The name and address of the initial director is as follows:

ARTICLE X - INDEMNIFICATION






