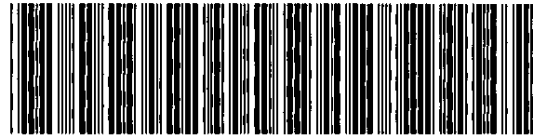

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act in compliance with Chapter 607 Florida Statutes (F. S.), do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation shall be Andrea Lewis & Associates, Inc.

ARTICLE TWO

DURATION

The duration of the corporation is perpetual.

ARTICLE THREE

PRINCIPLE OFFICE

The principal place of business/mailling address is 8869 Winged Foot Drive, Tallahassee, Florida 32312.

ARTICLE FOUR

PURPOSES

The general purpose for which the corporation is organized is to transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE FIVE
SHARES OF STOCK

The aggregate number of shares which the corporation is authorized to issue is Five Thousand (5,000). Such shares shall be of a single class, and shall have the par value of One Dollar (\$1.00) per share.

(2) Any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock of the corporation of any class or classes, or to which is attached or pertinent any warrant or warrants or other instrument or instruments conferring on the holder the right to subscribe for or purchase from the corporation any shares of its stock of any class or classes.
