

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation is
RIVERCREST FARM EQUESTRIAN CENTER INC.

This corporation shall have perpetual existence.



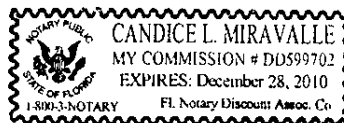


