THE UNDERSIGNED, has executed the following document as incorporator of the above ----- named corporation, a corporation organized under the laws of the State of Florida, and all the -- right duties and obligations of the undersigned as incorporator, and those of the corporation, are to determined in accordance with the laws of the a State of Florida.

ARTICLE I

The name of this corporation shall be: O.M. ELECTRIC BUCKET TRUCK, CORP

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida and shall have perpetual existence.

ARTICLE III

To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer and otherwise dispose of all or any part of its property and assets;

To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statute S607.141;

To purchase. Take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, ----- employ, sell, mortgage, lend, ledge or otherwise dispose of and otherwise use and deal in and with shares or other interest in, or obligations of, other domestic of foreign ----- corporations associations, partnerships or individuals or direct or indirect obligations of the United States or of any other government, stat, territory, governmental district or municipality or of any instrumentality thereof;

To be a promoter, incorporator, partner, member, associate or manager of any corporations partnership, joint venture, trust or other enterprise.


ARTICLE IV


