The undersigned incorporator for purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Article of Incorporation:

Article I. The name of the corporation is Action Kid Shots, Inc.

Article III. The Corporation is organized for the purpose of transacting any and all lawful activities or business for which corporations may be formed under Chapter 607 of the Florida Statutes.

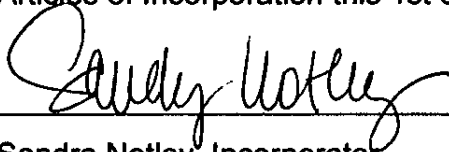

Article X. The corporate existence of the Corporation shall commence on July 1, 2007.

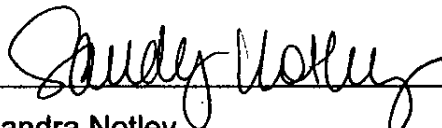
