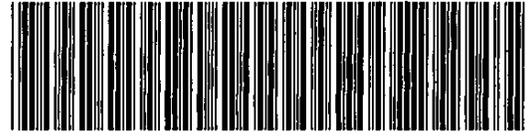

ARTICLES OF INCORPORATION

OF

STEPHEN J. RODNEY, P.A.

The undersigned subscriber to these articles of incorporation, being duly licensed to practice as a Hearing Aid Specialist under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, Chapter 621, Florida Statutes and other laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of the corporation is STEPHEN J. RODNEY, P.A.

ARTICLE II

PURPOSE

The Professional Corporation is formed to engage in every phase and aspect of the practice of a Hearing Aid Specialist. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE III

PROFESSIONAL SERVICES

The professional services of the Corporation shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized to practice as a Hearing Aid Specialist within the State of Florida. Professional services shall be rendered in each case by the officer, employee, or agent designated solely by the Corporation, acting through its duly elected officers. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of the practice of a Hearing Aid Specialist.

ARTICLE IV

CAPITAL STOCK

The Corporation is authorized to issue and have outstanding at any one

time an aggregate number of one hundred (100) shares of one class of common stock having a par value of one (\$1.00) Dollar per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

ARTICLE V

PREEMPTIVE RIGHTS

The shareholders of this Corporation shall be vested with full preemptive rights.

ARTICLE VI

INDEMNIFICATION

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law, except as to suits by such officer or director against the corporation.
