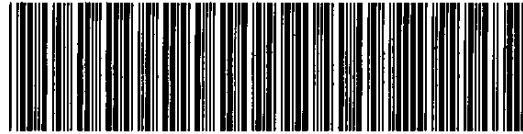



ARTICLE ONE

The name of the corporation is Dolphin Industries, INC. The principal office of the corporation is 3800 Josie Lane, Suite 3, Palm Harbor, Florida 34685.

The period of duration is perpetual.

The Board of Directors is empowered to make, alter or repeal the bylaws of the corporation without restriction of their powers conferred by statute.



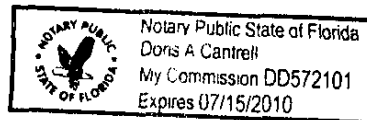


