**ARTICLES OF DISSOLUTION OF
JUNTO ARCHITECTS, PA**

The undersigned, being the President of JUNTO ARCHITECTS, PA, a Florida professional corporation (the "**Corporation**"), executes the following Articles of Dissolution pursuant to Section 607.1403 of the Florida Business Corporation Act:

1. The legal name of the Corporation is JUNTO ARCHITECTS, PA (Florida Division of Corporations document number P07000077732), and the Corporation's Articles of Incorporation were filed on July 6, 2007.

2. The written action to dissolve the Corporation was approved by all of the members of the board of directors of the Corporation on April 25, 2018.

3. The written action to dissolve the Corporation was approved by the holders of all issued and outstanding shares of the Corporation's voting common stock, representing sufficient votes to authorize such action pursuant to the Florida Business Corporation Act. The Corporation has no voting groups other than the above referenced voting common shareholders.
