ARTICLE OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
W. GREGORY GOLSON, P.A.

Pursuant to the provisions of Sections 607.1006 and 607.0401 of the Florida Business Corporation Act and Section 621.13 of the Florida Professional Service Corporation and Limited Liability Company Act, **W. GREGORY GOLSON, P.A.**, a Florida professional corporation (the "Corporation"), document number **P07000077762**, has adopted the following amendment to its Articles of Incorporation filed on **July 5, 2007**:

1. The Corporation's Articles of Incorporation are hereby amended by deleting Article I in its entirety and substituting, in lieu thereof, a new Article I to read as follows:

"Article I: Name

The name of the corporation shall be:

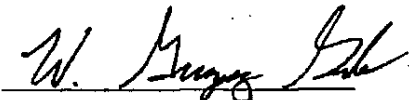
GOLSON LEGAL, P.A."
