**ARTICLES OF INCORPORATION**

The undersigned incorporators associate themselves with the intention of forming a professional corporation pursuant to Chapters 607 of the Florida Statutes and adopt the following articles of incorporation for the corporation:

ARTICLE ONE

NAME

The name of the corporation is Shutterup-Shutterdown.com Inc.

ARTICLE TWO

PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is 6850 Aliso Ave., West Palm Beach FL 33413. The name of the initial registered agent, located at 12955 SW 83<sup>rd</sup> Ct. Pinecrest, FL 33156, is Richard M. Gregg, Esq.

ARTICLE THREE

DURATION

The period of the corporation's duration shall be perpetual, or until dissolved on a vote of the shareholders as provided in these articles.

ARTICLE FOUR

PURPOSE

The purpose of this corporation is to engage in the service of installing and removing hurricane panels, but it may engage in any lawful business.

## ARTICLE FIVE

### CAPITAL STOCK

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is 100,000 shares. These shares shall be of a single class of common stock, and shall have no par value.

## ARTICLE SIX

### TAX ELECTION

The corporation shall elect Subchapter S tax status, until otherwise notified.

### DISSOLUTION

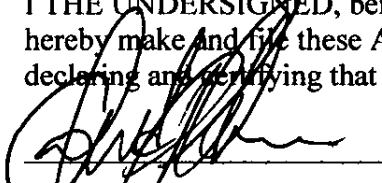

The corporation reserves the right to alter, amend, change or repeal and provision contained in this Articles of Incorporation.

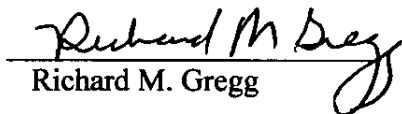
