Pursuant to the provisions of Section 607.1003 and Section 607.1006 of the Florida Business Corporation Act, YORK + DAVIS DESIGN STUDIO, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I
Name

The name of the corporation is YORK + DAVIS DESIGN STUDIO, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on July 9, 2007.

ARTICLE II
Amendment

Article I of the Articles of Incorporation of this Corporation is hereby amended for the purposes of changing the name of the corporation by deleting the existing Article I in its entirety, and substituting the following therefore to wit:

"Article I
Name

The name of the corporation is "JUNTO INTERIOR DESIGN, INC."

ARTICLE III
Date of Adoption


