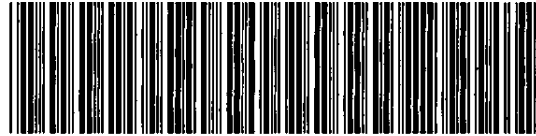

**ARTICLE I - Name**

The name of this corporation is BLING BLING SISTERS, INC.


