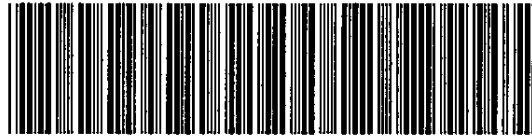

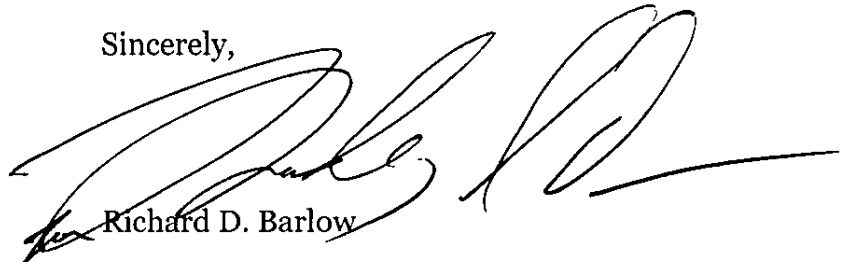

#### **ARTICLE VII. DIRECTORS**

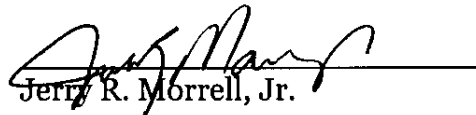

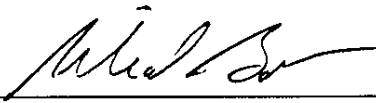
