**ARTICLES OF AMENDMENT TO ARTICLES OF
INCORPORATION OF ICHFLOW, INC.**

ICHFLOW, Inc., a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article IV in its entirety and by substituting, in lieu thereof, the following:

**ARTICLE IV
STOCK**


IV. Stock. The aggregate number of shares of stock authorized to be issued by this corporation shall be 1,000 shares of common stock, each with a par value of \$.001. The common stock will be divided into 500 shares of voting common stock and 500 shares of nonvoting common stock. Except for the right to vote, the rights associated with the voting common stock and nonvoting common stock shall be identical.

2. The foregoing amendment shall become effective as of the date of filing with the Florida Department of State, Division of Corporations.

3. The amendment recited in Section 1 above has been duly adopted in accordance with the provisions of §607.1006, Florida Statutes. The amendment was approved by all shareholders.
