**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Murray's Auto Supply, Inc. #8. Its principal office address and business mailing address is 15781 NW 7<sup>th</sup> Avenue, Miami, Florida 33169.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

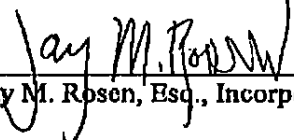
