ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is TAMAKUN INVESTMENT CORP.

- 6. To make contracts and guarantees and incur liabilities, horrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
