**ARTICLES OF INCORPORATION
OF
CAA INVESTMENTS HOLDINGS, INC.**

ARTICLE I - NAME

The name of the corporation is **CAA INVESTMENTS HOLDINGS, INC.** (the "Corporation").

ARTICLE II - ADDRESS

The address of the principal office and the mailing address of the Corporation is 8181 NW 154th Street, Suite 110, Miami Lakes, Florida 33016.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The Board of Directors shall fix the consideration to be received for each share. ARTICLE VI - COMMENCEMENT AND DURATION

The Corporation shall commence on the date on which these Articles of Incorporation are filed with the Secretary of State of Florida and the Corporation shall have perpetual existence.
