ARTICLES OF INCORPORATION
OF
SUSAN SAXE, M.D., P.A.

The undersigned subscriber to these Articles of Professional Service
Corporation, being natural persons competent to contract, and admitted to practice as a modical physician under the laws of the State of Florida, desires to establish a Professional Service Corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is: SUSAN SAXE, M.D., P. A.

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is: the practice of medicine by graduate physicians licensed to practice in the State of Florida, the furnishing of related clinical services and the lease or purchase of such real and personal property as is necessary for the rendering of this practice.

The investment of funds in real estate, mortgages, stocks, bonds, or any other type of investments.

- 3. No stockholder of the corporation may sell or transfer his stock in this corporation except to another individual who is eligible to be a stockholder of the corporation.
