

ARTICLES OF INCORPORATION

OF

CLASSIC TRADES, INC. A NEW FLORIDA CORPORATION

The undersigned subscribers to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is: CLASSIC TRADES, INC., a new Florida Corporation. The mailing and business address of the corporation is: 7541 Snead Ctanal Naples, FL 34113.

The general nature of the business is construction and home remodeling.
