The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapters 607 and 621 of the Florida Statutes

ARTICLE I - NAME

The name of this corporation is KYRIA POPOVITCH, P.A. (Hereinafter, "PA").


