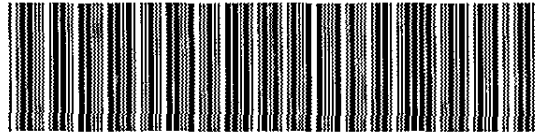

ARTICLE I - NAME

The name of this Corporation is Seminole Siteworks, Inc. and the address is 5065 Ohio Avenue, Sanford, Florida 32771.

ARTICLE II - TERM OF EXISTENCE

ARTICLE III - NATURE OF BUSINESS

These Articles of Incorporation may be amended only by the vote or written consent of the holder of seventy-five percent (75%) of the outstanding shares entitled to vote.

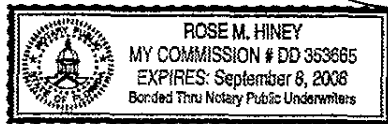
