ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF 1ST MANATEE BANK



Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of 1st Manatee Bank are hereby amended as follows:

<u>FIRST</u>: Article III-A. of the Articles of Incorporation is hereby amended by deleting the text thereof in its entirety and substituting the following in lieu thereof:

ARTICLE III

Capital Stock

A. Number and Class of Shares Authorized; Par Value.

The Corporation is authorized to issue the following shares of capital stock:

- (1) <u>Common Stock</u>. The Corporation shall have authority to issue 7,000,000 shares of common stock with a par value of \$5.00 per share (referred to in these Articles of Incorporation as "Common Stock").
- (2) <u>Preferred Stock</u>. The Corporation shall have authority to issue an aggregate of 2,000,000 shares of preferred stock with a par value of \$1.00 per share (referred to in these Articles of Incorporation as "Preferred Stock").

SECOND: The foregoing amendment was adopted by the holders of in excess of a majority of the outstanding shares of common stock, being the sole voting group entitled to vote on the amendment, on April 21, 2015 and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.
