ARTICLE ONE NAME

The name of this Corporation shall be:

ARTICLE TWO NATURE OF BUSINESS

Any lawful husiness conducted within the laws of the State of Florida

ARTICLE THREE TERM OF EXISTENCE

This Corporation shall have perpetual existence, unless somer dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: IULY 11, 2007.

ARTICLE FOUR MINIMUM CAPITAL

The amount of capital with which the Corporation shall begin business shall not be tess than Five Hundred (\$500.00) Dollars, or such greater amount as may be required by law.

ARTICLE FIVE NUMBER OF DIRECTORS

- (f) Voting Rights: Each share of Common Stock shall entitle the record holder thereof to one (1) vote upon each proposal presented at meetings of the stockholders of the Corporation.
- (g) Cumulative Voting: No notder of Common Stock shall be entitled to any right of cumulative holding.
- (h) Dividends: Record holders of Common Stock are entitled to receive their pro-rata share of any dividends that may be declared by the Board of Directors out of assets legally available for such purpose.

(i) Liquidation Rights: Holders of Common Stock are emitted, in the event of the liquidation or dissolution of this Corporation to receive their pro-rate share of any assets of this Corporation remaining after payment of all corporate debts and obligations.

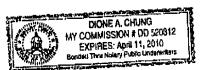
