ARTICLES OF INCORPORATION OF DENTAL ASSOCIATES OF HOLLYWOOD, P.A. A Florida Professional Service Corporation

The undersigned, acting as incorporator of a professional service corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation for such professional corporation:

ARTICLE I NAME, ADDRESS AND REGISTERED AGENT

- 1.1 Name. The name of the professional service corporation shall be DENTAL ASSOCIATES OF HOLLYWOOD, P.A. (the "Corporation").
