#### ARTICLES OF INCORPORATION OF FORANA CORP.

## ARTICLE I. NAME

The name of the corporation is: FORANA CORP.

## ARTICLE II. NATURE OF BUSINESS

This corporation may engage in the transaction of any or all lawful business permitted under the laws of the United States and the Florida General Corporation Act.

# ARTICLE III. CAPITAL STOCK

No contract or other transaction between this corporation and any other firm or corporation and no act of this corporation shall in anyway be affected or invalidated by the fact that any of the Directors of the corporation are pecuniarily or otherwise interested in or are Directors or Officers of such other firm or
