ARTICLES OF INCORPORATION

The name of this corporation is MARANATHA CARIBBEAN MART, INC...

11.

The term for which this corporation shall exist shall be perpetual.

III.

The general nature of the business or businesses to be transacted by said corporation shall be as follows:
