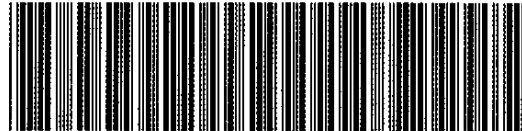

ARTICLE I - NAME

The name of this corporation is Ocean Star International, Inc.

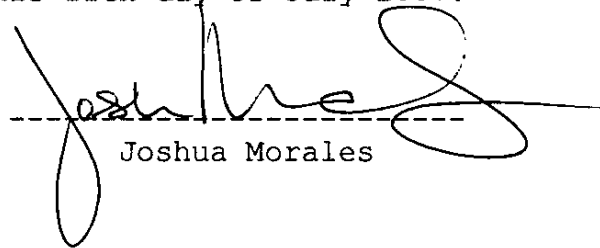

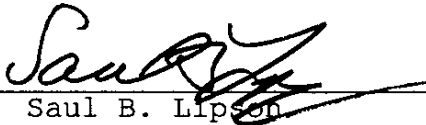
