**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is RAVEN PUBLISHING, INC., and its principal office and mailing address is 401 East Jackson Street, Suite 2225, Tampa, Florida 33602.

**ARTICLE II**

**Commencement of Corporate Existence**

The corporation *shall have perpetual existence.*

**ARTICLE III**

**General Nature of Business**

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.
