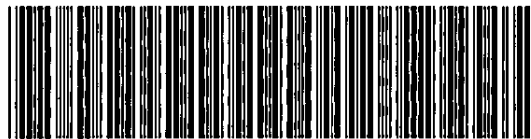

THE UNDERSIGNED, acting as Incorporator of the BUZAN FUNDING SOLUTIONS, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following ARTICLES OF INCORPORATION for such corporation:

ARTICLE I

NAME

The name of the Corporation shall be:


