ARTICLES OF INCORPORATION OF YEBRA HOUG INSPECTION COMPANY, INC.

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION
